1 Title

This is the Civil Defence National Emergencies (Information Sharing) Code 2020 Amendment No 1.

2 Commencement

This amendment comes into force on 1 May 2026.

3 Clause 6 (Collection, use and disclosure of personal information for permitted purpose) amended

In clause 6 of the Civil Defence National Emergencies (Information Sharing) Code 2020,—

- (a) insert subclause 6(1)(c)(iv):
a person who is responsible for the individual (within the meaning of clause 5(3));
and
- (b) delete subclause 6(1)(d).

Explanatory note

This note is not part of the code of practice amendment but is intended to indicate its general effect.

This amendment amends the Civil Defence National Emergencies (Information Sharing) Code 2020 to correct a technical error with the numbering of clause 6. It is intended to provide clarity that agencies may disclose personal information to a person who is responsible for an individual for the permitted purpose (as those terms are defined in the Code).
